Congruent with the promotion of international co-operation and friendship in the fields of education and research, Shree Mouni Vidyapeeth's (SMV), Karmaveer Hire Arts, Science, Commerce and Education College (Affiliated to Shivaji University, Kolhapur), Gargoti (India), and the University of Malta (Malta).

This Memorandum of Understanding between the two institutions represents a statement of intent by the parties herein to work together for furthering international co-operation in education and research in the common interests of the two institutions and their respective countries.

In this interest:

Shree Mouni Vidyapeeth's (SMV), **Karmaveer Hire Arts, Science, Commerce and Education College**, Gargoti (India), (Affiliated to Shivaji University, Kolhapur), (hereinafter referred to as the "College" and herein represented by Dr. P. B. Patil, having Passport Number N2264971 and acting in his capacity as Principal of College,

And

The University of Malta (hereinafter referred to as the "UM"), having its registered address at Msida, MSD 2080, and herein represented by Prof. Alfred J. Vella, holder of Identity Card Number 919150 (M), Rector,

Individually referred to as a "Party" and jointly referred to as "the Parties",

Declare their willingness to collaborate and promote international educational initiatives, which include but not limited to the areas stated in the current Memorandum of Understanding

1. Legal Framework of Both Parties

Shree Mouni (SMV) is one of the oldest and prestigious institutes in south-western Maharashtra region of India. It was established in 1951 under the visionary leadership of an eminent educationist and social reformers Late Padmbhushan Dr. J. P. Naik and Late Raosaheb Dr. V. T. Patil with the Motto, "Rural reconstruction through education and education through rural reconstruction." The 'SMV' has successfully grown over the years running more than 28 educational institutes right from primary to post-graduation studies in several disciplines of Arts, Commerce, Science, Education, Composite Training Centers, Engineering, Polytechnic, etc. The



President of the SMV may initiate agreements with foreign institutions of higher education to enhance international goodwill and understanding through programs of academic exchange.

The UM is the highest public educational institution in Malta, having its own separate legal personality and autonomy established by virtue of Article 72A of Chapter 327 of the Laws of Malta (the Education Act). Through the expertise present in its multidisciplinary Faculties, Institutes, Centres and Schools, it is committed to develop and support collaboration, including, inter alia, through collaborative R&D, joint funding applications, consultancy, and laboratory services.

2. Common Interests and Objectives

By reason of their very essence, both Parties share interests and objectives in academic exchange and scientific research matters. Both Parties are interested in establishing academic cooperation agreements with institutions of similar nature in order to assist in the achievement of their goals and objectives in such matters.

3. Purpose

A. The purpose of this Memorandum of Understanding (“MOU”) is to establish a collaboration among the Parties to further the goals set forth below (the “Goals”):

- a) Development of joint scientific and/or technological research projects
- b) Exchange of eligible research personnel
- c) Any other activity of mutual interest regarding academic or scientific and technological research matters.

- B.
 - i. The Parties maintain their own separate and unique missions and mandates, and their own accountabilities including accountabilities towards third parties.
 - ii. Cooperation among the Parties as outlined in this MOU shall not be construed in any form or manner as to create a partnership, exclusive rights, a joint-venture, an agency or other type of legal entity or personality.
 - iii. Each Party shall accept full and sole responsibility for any and all expenses incurred by it relating to this MOU.



- iv. Nothing in this MOU shall be construed as superseding or interfering in any way with any agreements or contracts entered into among the Parties, either prior to or subsequent to the signing of this MOU.
- v. Nothing in this MOU shall be construed as an exclusive working relationship and the Parties acknowledge that either Party may enter into identical or similar agreements with third parties both during and after the duration of this Memorandum.
- vi. The Parties specifically acknowledge that there are no financial implications resulting from this MOU nor does it constitute a legally binding commitment by any Party or create any rights towards any third party.
- vii. The Parties agree that separate and more specific agreements may be entered into between the Parties focusing on relevant aspects on which the Parties wish to collaborate further

4. Effective Date, Duration, Amendments and Termination

The initial term of this MOU will be for a period of five(5) years commencing on the date it is signed by both Parties. The MOU shall automatically be renewed for a maximum of four (4) year terms, unless a written notification of intent to terminate the agreement is received at least sixty (60) days prior to the renewal date, provided that in the event of early termination (both during the initial term as well as during the renewed term) the Parties shall honor any obligation which they had committed to. Any changes or other consideration to this MOU shall be made only by the mutual consent of both Parties and appended to this document in writing. This MOU does not commit either Party to signing any other activity agreement. The Parties will retain full discretion to choose to participate in any other activity. For legal purposes, nothing in this MOU shall be construed as creating joint venture, an agency relationship, or legal partnership between the Parties. This MOU shall come into effect upon the date of last signature set forth below.

5. Communications

A. Confidentiality

Both Parties are aware that in the course of collaboration under this MOU they will have access to and be entrusted with confidential information in respect of the business of the



Parties and their dealings, transactions and affairs, all of which will be treated confidentially unless required by law or by a Court of law or unless otherwise indicated.

The Parties shall not divulge any information relating to the other Party that shall come to their knowledge in the course of the collaboration, nor shall either Party at any time make use of such information for its personal advantage or for that of third parties. The Parties may be required to sign a non-disclosure agreement or an acknowledgement of undertaking that the other Party may deem necessary or advisable to safeguard the confidentiality of its operations.

B. Intellectual Property

All background Intellectual Property will remain the ownership of the originating Party. Access to such Intellectual Property will be negotiated on a case by case basis in the Specific Agreement.

Any Intellectual Property generated as a consequence of the collaboration hereunder will be owned by the Party creating the same, unless otherwise negotiated on a case by case basis in the Specific Agreement.

With regard to any Intellectual Property generated jointly by the Parties as a consequence of the collaboration hereunder, the Parties will establish a written separate agreement regarding the allocation of ownership and terms of exercising, protecting, and the division of related costs and exploiting such joint Intellectual Property on a case by case basis.

Licences for the exploitation of Intellectual Property will be negotiated on a case-by-case basis in the Specific Agreement.

C. Promotional Material And Use Of Names And Logos

Any use of the name including but not limited to the trademark and logo of either Party will require written permission from the other Party. All joint promotional materials shall





bear the official corporate logos of all concerned Parties and be subject to editorial checks, according to the Parties' internal procedures.

D. Data Protection

Personal data will be used and processed only for the purpose of the present Agreement and consequent executive Specific Agreements in accordance with the data subjects' rights, fundamental freedoms, respect of dignity, confidentiality, personal identity and their right to personal data protection in terms of the Data Protection Act (Chapter 440 of the Laws of Malta) and the regulations made thereunder

E. Coordination and Follow-Up

The two main respective Parties' representatives shall be Dr. Sharadrao A. Vanalakar from the College and Prof. Luciano Mule Stagno from the UM, who will be responsible to initiate and lead the various initiatives subject to this MOU. The representatives shall involve other persons from their organization as necessary including the setting up of steering groups as necessary from time to time. All notices shall be in the writing and shall be directed to these individuals as follows:

6. Force Majeure

- A. Where any of the Parties are affected by *Force Majeure*, the affected Party shall immediately inform and provide the other Party with details in writing and keep the other Party fully informed of the continuance of the *Force Majeure* and of any change in circumstances. Both Parties shall endeavour to implement solutions to any problems that may arise.
- B. In the event of *Force Majeure*, and subject to there not being any remedy to the ensuing situation, neither Party shall be considered to be in a breach of this MOU, nor shall either Party be liable to the other, by reason of any delay in performance, or non-performance of any of its obligations due to *Force Majeure*.

7. Governing Law - Dispute Resolution

This Agreement shall be governed by, construed and interpreted in accordance with the laws of Malta. The UM and the Company agree to amicably settle any dispute arising in relation to this Agreement. If the Parties fail to reach such an amicable settlement within twenty (20) days, the dispute shall be settled by the competent Courts of Law in Malta.

8. Assignment

Neither Party shall assign, transfer, or subcontract this Agreement or any of its obligations hereunder without the prior written consent of the other Party.

9. Signed

४. निबंध, वक्तृत्व, वाद-विवाद, प्रश्नमंजुषा, कथालेखन, काव्यलेखन, काव्यवाचन, कथाकथन स्पर्धांचे आयोजन करणे.
५. स्पर्धा परीक्षा मार्गदर्शन केंद्रासाठी सहकार्य करणे.
६. व्यक्तिमत्त्व विकास प्रकल्प, कौशल्य विकास प्रकल्प राबविणे.

७. दरवर्षी कोल्हापूर, सांगली, सातारा या शिवाजी विद्यापीठाच्या कार्यक्षेत्रामध्ये संघाचे वार्षिक एक/दोन दिवसांचे अधिवेशन विविध साहित्यिक विषयांवर घेणे. सदर अधिवेशनात प्राध्यापकांच्या शैक्षणिक तसेच विषयांच्या समस्यांवर चर्चा करणे.
८. सर्जनशील लेखन, उपयोजित मराठी लेखन प्रकल्प राबविणे.
९. मोडी लिपी, मुद्रितशोधन, पत्रकारिता इत्यादी अभ्यासक्रमांचे आयोजन करणे.
१०. ग्रंथ प्रकाशित करण्यासाठी सहकार्य करणे. ग्रंथाचे प्रकाशन व चर्चा घडवून आणणे.
११. मराठी भाषा, साहित्य आणि संस्कृती या संबंधाने येणाऱ्या समस्या व अडचणी विद्यापीठ, शासन आणि विद्यापीठ अनुदान आयोग, दिल्ली यांना यासंदर्भात सूचना-पत्रव्यवहार करणे.

एकमेकांना सहाय्य करण्याची प्रस्तावित माध्यमे

१. परस्पर हिताच्या शैक्षणिक बाबींमध्ये तसेच प्रशिक्षणामध्ये सहकार्य करणे.





3. This Memorandum of Understanding comes into effect from the date of its signing and will remain into force initially for three years. The validity may be extended by mutual agreement between the two institutions.
4. This Memorandum of Understanding may be revised or terminated upon mutual consultation between the two institutions.

Based upon the Memorandum of Understanding (MoU) for academic exchange and Co-operation between The Principal, Karmaveer Hire Arts, Science, Commerce and Education College, Gargoti, Tal – Bhudargad, Dist – Kolhapur, 416 209 and The Principal, Sadashivrao Mandlik Mahavidyalaya, Murgud, Tal – Kagal, Dist – Kolhapur- 416 219 this annexure pertains to collaboration in awareness and career oriented programmes for students in college. The above parties therefore mutually agreed to sign this annexure to the MoU.

1. This annexure, to the MoU superseded all previous correspondence and discussions.

2. Broad objectives:

- To create awareness among science students regarding animal diversity and its conservation and to aware them about career options in future.
- To use and share preserved specimens, libraries, database, documentation and instrumental and other related infrastructure facilities.
- To involve the students in community services activities.
- To organize seminars, workshops and guest lectures for the students.

3. Role and responsibilities of Karmaveer Hire College, Gargoti and Sadashivrao Mandlik College, Murgud:

Both the institutions Karmaveer Hire College, Gargoti and Sadashivrao Mandlik College, Murgud shall jointly undertake career oriented programmes for students and involve in community services that are agreed upon by both the parties. The students and staff visiting the institutions shall be provided with necessary facilities.

Both the institutions shall maintain documentary records for performance of seminars, visits, campus interviews, and placements, community services done etc. including both successes and failures and shall share these records equitably. Each institution shall build on their respective strengths and shall clearly identify the roles in developing and implementing the programmes.

Any amendment to this annexure shall be made after consultation and mutual written consent.

4. Confidentiality clauses:

The sharing and dissemination of academic and vocational along with placement record and partnership generated in the course of this collaboration shall be worked out jointly by Karmaveer Hire College, Gargoti and Sadashivrao Mandlik College, Murgud in keeping with their mutual interest and overall objectivities of this MoU.

5. Programme monitoring group:

There shall be a programme monitoring group established at each institution whose composition shall be as follows:

Chair person	:	Principal
Co-coordinator	:	Vice Principal
Members	:	Two nominees from Head of the departments
	:	Two teacher nominee
	:	One administrative nominee

The programme Monitoring Group shall have a joint meeting at least once in a year alternatively in each institution. Programme monitoring group of both the institutions shall meet at least on an annual basis, preferably in March –May to identify and develop collaborative activities and to determine year plan for the following academic year.

6. Financial Terms and mode of payment if any:

Both the institutions shall not demand any monetary charges from each other for the use of technology and know-how for their own internal use for the purpose of performing community services and programmes organized in the institution.

7. Non-exclusive Nature of MoU :

This MoU between Karmaveer Hire College, Gargoti and Sadashivrao Mandlik College, Murgud is and shall be non-exclusive in its nature for all parties and shall not come in the way of either partners form collaboration with the third party except as restricted by confidentiality clause.
